1. Minutes of the Last Meeting (10 May 2012) / Matters Arising

 The minutes had been circulated and were agreed except for the figures for the Club evenings, where the grant had been quoted as expenses. An amended paragraph will be supplied to David Jukes for inclusion in a revised set of minutes.

2. Membership

- No new members since the last meeting. Summer is normally a quiet time.
- The impact of the new BOF membership structure was discussed. National membership is to be considerably cheaper, with higher event levies to make up the income. Some categories of membership, such as family and student, will be disappearing, although assurances have been given that the BOF database will still support these if clubs wish to offer them. The club needs to decide whether to align with the new BOF structure. Peter reported that annual club income from membership was budgeted for the current year as £879, with £438 received to date. By comparison, event income for last year was over £4000. We only have around 10 local members. It was felt that we could lose some members if we drop family membership, but that these would be mostly inactive orienteers.
- It was felt that we needed more information before making a final decision. Ian was asked to
 investigate how many Family members we have, to try to give some idea of the composition of
 these, and circulate this information before the next committee meeting. Peter was also asked
 if he could work out possible scenarios for different levels of fees.

One potential problem of dropping family membership is that we could end up sending several
newsletters to the same address. It was mooted that the newsletter could be emailed and/or
distributed at events, saving the substantial cost of postage. An agenda item for discussing
membership structure and fees will be required for the next committee meeting.

 before the bracken has died down and rhododendrons cut back, or the mapper will spend ages
 mapping thickets which may be removed before the event.
- Cold Ash is being remapped for the JK. It could be used for the Concorde Chase in 2015.

6. Treasurer's Report

Peter circulated updated accounts which were discussed.

- We are currently running at a small loss on the Saturday Park series. This is mainly due to the
 cost of maps the longer courses require A3 maps on waterproof paper. These have to be
 professionally printed, which makes these much more expensive than the other Saturday
 events.
- We need to consider the entry fees for Saturday events, as these will be liable for BOF levy from the start of next season. The following entry fees were decided upon:
